I am extremely concerned about the proposed exemptions for industry that undermine the purpose of Ontario's new Endangered Species Act (ESA). The following points outline my key concerns:

- The forestry industry must be required to fully comply with the new ESA. The forestry exemption should be withdrawn.
- The proposed exemption for forestry, quarries and development should not apply to the 42 species covered under the old ESA.
- The hydro-electric exemption should require that all reasonable steps be taken to minimize harm and reach an "overall benefit" for affected species. It should also require that any agreements reached be subject to public scrutiny and comment on the Environmental Bill of Rights Registry. The exemption period should be reduced, allowing operators one year, rather than three, to reach an Agreement with the government about mitigating impacts.
